3. You understand and acknowledge that neither the Company nor any of the Company's representatives makes any representation or warranty, express or implied, as to the accuracy or completeness of the Evaluation Material. You agree that neither the Company nor any of its representatives shall have any liability to you or any permitted party arising from or relating to the use of the Evaluation Material or any errors or omissions contained therein.
4. You hereby agree that the Evaluation Material will be used solely for the purpose of evaluating a possible transaction involving the Property, and that such material will be kept confidential by you in accordance with the terms of this Agreement.

This Agreement embodies the full understanding of the parties and supersedes any prior communications or agreements, whether written or oral, relating to its subject matter. This Agreement shall be governed by and construed in accordance with the laws of the State of New York. We acknowledge that the provision of the Income and Expense Material is subject to the execution of this letter agreement and its approval by the Owner.
